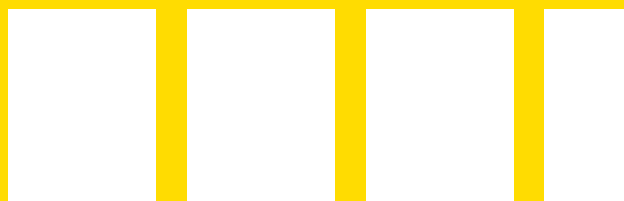

The Crane

A crane is a *lifting machine* equipped with a *winder, wire ropes or chains and sheaves* that can be used both to lift and lower materials and to move them horizontally. It uses one or more simple machines to create *mechanical advantage* and thus move loads beyond the normal capability of a human. Cranes are commonly employed in the *transport industry* for the loading and unloading of freight; in the *construction industry* for the movement of materials; and in the *manufacturing industry* for the assembling of heavy equipment.

The first cranes were invented by the *Ancient Greeks* and were powered by men or beasts-of-burden, such as donkeys. These cranes were used for the construction of tall buildings. Larger cranes were later developed, employing the use of human treadwheels, permitting the lifting of heavier weights. In the *High Middle Ages*, harbour cranes were introduced to load and unload ships and assist with their construction – some were built into stone towers for extra strength and stability. The earliest cranes were constructed from wood, but cast iron and steel took over with the coming of the *Industrial Revolution*. For many centuries, power was supplied by the physical exertion of men or animals, although hoists in watermills and windmills could be driven by the harnessed natural power. The first 'mechanical' power was provided by steam engines, the earliest steam crane be-
